Description

Luban HP3107K is a polypropylene homopolymer designed for the production of biaxially oriented polypropylene films (BOPP). The product is suitable for metallizable film, both as monolayer and in coextruded structures.

Processing Guidlines

The Typical Processing Conditions for Luban HP3107K are:

Extrusion Temperatures $200 - 250 \,^{\circ}\text{C}$ Chill Roll Temperature $20 - 40 \,^{\circ}\text{C}$ MD Stretching Temperature $130 - 160 \,^{\circ}\text{C}$ MD Stretching Ratio4 - 7TD Stretching Temperature $155 - 170 \,^{\circ}\text{C}$ TD Stretching Ratio7 - 10

Storage and Handling

Luban HP3107K should be stored in well ventilate area during handling or processing of to prevent accumulation of dust and fumes. Avoid contact with strong oxidizers, excessive heat, sparks or open flame as this could well speed up alteration and consequently loss of quality of the material in which could lead to unforeseen dangers. The bags must be protected from direct sunlight and should be stored in shaded and completely dry area for good processing.
